If you are a new applicant for the 2018-2019 school year, you must call the Information Center at (914) 377-8012 to schedule an appointment to register your child with the school district. You will need a birth certificate and three (3) proofs of residency. See reverse side for required documents.

All Applications for Non-Public School Bus Service are to be delivered in person to the Transportation Department at One Latin Center, Yonkers, NY 10701 – (914) 377-8012.
